And

K.D. College, having its administrative office at Simbhaoli, Hapur U.P., will be hereinafter be called as the Second party.

WHEREAS, A.K.P Degree College, Khurja and K.D. College, Simbhaoli (Hapur) have common objectives of imparting education, training and placements to students under NEP 2020.

AND WHEREAS, in order to encourage close research and development and co-curricular ties A.K.P. Degree College, Khurja and K.D. College, Simbhaoli (Hapur) are willing to cooperate for conducting joint activities in common areas of interest and benefit both the colleges for research and education purposes.

AND WHEREAS, A.K.P. Degree College and K.D. College desire to enter into a MoU which will serve as a general framework for cooperation between the two colleges and to facilitate discussions of specific programs.

AND WHEREAS, the activities under the MoU will be carried out through the Principal of A.K.P. Degree College, Khurja and the principal of K.D. College, Simbhaoli (Hapur)

Both A.K.P. Degree College and K.D. College jointly agree:

- 1.** To jointly organize seminars, conferences, workshop, Symposium and Panel Discussion etc. on the topics of mutual interest and to invite each other's members to participate therein.
- 2.** For implementing NEP-2020 at UG and PG level both college will apply University specialization at college level also and would work for it accordingly.
- 3.** To collaborate in Humanities, Literature , Social Sciences for collaborative research programmes and will ensure their facilities and faculties accordingly.
- 4.** To share their programme agendas, best practices and different formats for NAAC evaluations and different rankings.
- 5.** For Academic and Administrative Audit (AAA) will select outer agencies based on mutual understanding.
- 6.** To allow faculty exchange and student exchange for different programs for effective learning based on mutual understanding under NEP-2020 programmes.
- 7.** To share the research results, research projects, dissertations and research papers jointly in collaborative projects
- 8.** To help each other students in the academic visit of both the campuses.
- 9.** This MoU is non-binding, non-enforceable and non-financial ramification, but rather a way of mutual understanding for increasing both organization a mutual synergic benefit.

Tenure and Termination: This MoU will take effect from the date it is signed by representatives of the two colleges. It will remain valid for five year, and may be continued thereafter suitable to review and agreement. Either college may terminate the MoU by giving written notice to the other college three months in advance. Once terminated neither, A.K.P Degree College nor K.D. College will be responsible for any losses, financial or otherwise; which the other college may suffer. However, A.K.P Degree College, Khurja and K.D. College, Simbhaoli will ensure that all activities in progress are allowed to complete successfully.
